Description of necessary first aid measures

Eye contact

Inhalation

Remove victim to fresh air and keep at rest in a position comfortable for breathing. If not breathing, if breathing is irregular or if respiratory arrest occurs, provide artificial respiration or oxygen by trained personnel. Section 6. Accidental release measures

Personal precautions, protective equipment and emergency procedures

For non-emergency personnel

Methods and materials for containment and cleaning up

Small spill

Precautions for safe handling

Protective measures


